In consideration of the acceptance of my application to hire, use, handle and ride horses, mules or ponies owned or provided by the Circle Bar B Stables, I HEREBY WAIVE, RELEASE AND DISCHARGE ANY AND ALL CLAIMS FOR A DEATH, PERSONAL INJURY OR FOR PROPERTY DAMAGE which I may have, or hereafter may accrue to me or my heirs, as a result of my participation in this activity.

I understand that serious accidents occasionally occur during the use, handling and riding of horses, mules and ponies. Knowing the risks of this activity, I nevertheless agree to assume those risks and to release in advance P.M.B. Stock Co. Inc., Circle Bar B Resort Inc., Circle Bar B Stables, Brown Ranch Partnership, all owners, employees, agents, property owners and the Florence F. Brown Revocable Trust, 1981 or anyone connected in any way with the Circle Bar B Stables from any and all liability arising out of or connected in any way with my participation in this activity EVEN THOUGH THAT LIABILITY MAY ARISE OUT OF SOLE NEGLIGENCE OR CARELESSNESS ON THE PART OF THE PERSONS OR ENTITIES MENTIONED ABOVE. In addition I understand that this release includes any accidents caused or contributed by the conditions of the land whether or not the condition is natural or man-made.

The conditions set forth in this agreement are the conditions that apply to me to enter upon the private Property of the Circle Bar B Ranch and to participate in the activity of horseback riding. I agree to accept and abide by the rules and instructions of the Circle Bar B Stables and the terms and conditions of this agreement.

THIS AGREEMENT SHALL BE AFFECTIVE AND BINDING UPON THE PARTIES HERETO FOR THE DURATION OF THEIR STAY AT THE CIRCLE BAR B RANCH. Should any dispute arise relating to the activity being released herein, then it is agreed that the prevailing party is entitled to reasonable court costs and attorney fees incurred in said dispute. This release also applies to people riding their privately owned horses.
